GENERAL CONDITIONS

Program for children – Conference „Children in permaculture“ ZČ HB FOREST, CEGV Cassiopeia, Jizerská 4, 370 11 České Budějovice General conditions are related to the registration form for the program for children

1. With the registration form, the child's parent (parents) or a legal representative commit to duties, which are laid down in these General Conditions document. The subject of the contract between the organizer of the program and the legal representative is the child's participation at the program for children at the conference „Children in permaculture“.
2. The participant on the children's program is the person, whose stay is supported by a properly completed registration form and a statutory declaration about the health of the child. Persons under the age of 18 let are in this contractual relationship represented by a person over the age of 18 (the child's legal representative). The legal representative assumes responsibility for fulfilment of the agreed conditions. The contractual relationship between the legal representative and the organizer starts and takes effect at the moment when the legal representative signs the registration form for the program.
3. The participant of the program is obliged to follow the rules of the kid's area and the instructions of the leaders of the program. Especially the instructions connected to safety and health of the participants of the program. The participant must avoid any behavior, that can harm other participants of the program. In case of unmanageable disciplinary problem with the participant, the organizer has the right to exclude the child from the program and entrust them into the care of their parents. The participant of the program must deal carefully with the property in the place of their stay.
4. The legal representative must introduce the rules laid down in this document to the child in an appropriate way before coming to the children's program, especially these points:
 - **Movement of children:** Children must not leave the room or area without the agreement of the leaders. When being outside - in a forest, a meadow, a garden, when playing games, the child must follow the instructions of the leaders of the program, must not go away from the group or from an agreed space. According to the instructions of the leaders, children must not go to specified places without the leaders' agreement.
 - **Instructions of the leaders:** Children must respect the instructions of the leaders.
 - **Health of the child:** Parents must tell the leaders about any health problems of the child. It is not allowed to use medicine without the agreement of the leader of the program (incl. own medicine, vitamins). If the child needs to take their own medicine, the parent must hand in the child's medicine to the leader of the program with written instructions when and how to use them, with the name of the child.
 - **Food:** The child must respect that he/ she is not allowed to pick wild berries and he/she has to drink enough.
 - **Good manners/ politeness:** Children should have good manners/ be polite (greeting, saying thank you/ please) and not to use swear words.
 - **Violence, bullying:** In case of violence or bullying it is necessary to let to know an adult (the leader of the program) about it.
5. CEGV Cassiopeia explicitly points out that because of the kind of event the organizer cannot be responsible for loss of valuable things such as: glasses, mobile phone, other expensive electronics, other valuable things (jewelry, watch,...).
6. For accepting the child to the program it is necessary to hand in: by a legal representative filled and signed **REGISTRATION FORM FOR CHILD, STATUTORY DECLARATION** and signed **GENERAL CONDITIONS**.
7. There will be legal and financial consequences for legal representative in case of health risk for individual child or the group caused because of untrue or incomplete information in the statutory declaration about the child's health state.
8. The participant of the program for children must respect the rules concerning their clothes and equipment (e.g. a raincoat) for the program. In case that the equipment (or clothes) is not appropriate, the leader can require from the legal representative buying the equipment (mentioned on the list of needed equipment) and accept the child after having required equipment.
9. Legal representative confirms by the signature of the Registration form and of General conditions that these documents are known to her/him and that she/he agree with them, will inform her/his child about the need to respect these general conditions and inform the child about consequences in case of breaching of these conditions.
